State law enables cable companies to terminate support for PEG access beginning January 1, 2009 in cases where local franchises have expired. Some cities are already planning large reductions to their governmental channel budgets. There is uncertainty about the future of PEG channels as cities reevaluate the resources needed to operate PEG channels in their community. PEG fees represent a new source of funding for PEG capital facilities, but do the limitations create difficulties in continuing operations under current operating models? Will new models emerge?
